Calendar Description

This special study option enables undergraduate students in semesters 5 through 8 to undertake specific projects in agricultural science. The topic of the special study will be determined in consultation with a faculty member and the individual student. Students are responsible for making appropriate arrangements with faculty member prior to registration for the course.

Restriction(s): Instructor consent required.

Course Description

This special study course enables undergraduate students in semesters 5 through 8 to undertake independent study projects in agricultural science. The project can range from experiential learning activities, a review of literature, conducting research, design and implementation and many others. The course is purposely quite flexible to provide an opportunity for students to pursue unique interests. The project for the special independent study will be determined in consultation between a faculty member and the individual student. Students are responsible for making appropriate arrangements for their project with a faculty member prior to contacting the course coordinator to register for the course. In order to register for the course, the course coordinator will provide additional paperwork for documenting the project prior to allowing a student to register for the course.

Course Learning Outcomes

1. This course is broadly configured to allow students an opportunity to work with a faculty member in a one-on-one situation. Learning outcomes vary widely depending upon the project that is defined between the advisor and the student. That being said, by the end of the course, students will develop and conduct an independent experiential learning project and through this effort develop and demonstrate an in-depth understanding of a specific aspect of agriculture science.

Accessibility

Drop Date
